We contribute to the application and enforcement of animal welfare and protection standards through legal means.



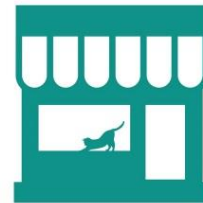
SHOW THE PET A CHRISTMAS TREE

WHAT WAS DONE
IN 2019?

WORK DONE:

- We appeared **in the media 124 times**, educating on animal welfare topics.
- We prepared **53 articles** and conducted **1 study** on the topic of animal welfare.
- We worked with **44 cases of animal neglect and cruelty**, of which 19 animals' living conditions were improved and/or the owner was punished in accordance with the procedure established by laws, for 9 we did not collect evidence to initiate legal actions, 8 informers disappeared during the course of work, 8 cases moved to 2020.
- In the "neBrisius.lt" project, we photographed and told **219 stories**, of which 15 were about emigrating pets with their owners, 6 about animals with special needs | www.nebrisius.lt.

WORK DONE:

- We added **221 new place** for people to bring their pets to the “Pet-Friendly” project | www.draugiskigyvunams.lt.
- We **consulted over 100 people** on animal welfare.
- We distributed over **20,000 handouts** on animal welfare topics.
- We filled the database of frequently asked questions about animal welfare -> **FAQ**.
- We distributed a quarterly animal welfare **newsletter**.
- We presented the [Activity Report 2018](#).

ORGANIZED:

- After the event “Show the pet a Christmas tree 2018”, we held a “likes” collection campaign, during which **12,075 portions of food** were donated to shelter pets. The sponsor of the event is “Mars Lietuva”, UAB.
- We organized the traditional event “Show the pet a Christmas tree 2019”, as a result of which **1,700 kg of food** (20,925 portions) were donated to shelters. The sponsor – “Mars Lietuva”, UAB. The event was shown by LNK žinios, TV3 žinios, “Labas rytas, Lietuva”, “Gyvūnu manija”. Video of the event.
- We organized an **exhibition of the “neBrisius.lt”** project in Vilnius “Akropolis”. This initiative was supported by “Mars Lietuva”, UAB, patronized by member of the Seimas Dovilė Šakalienė.
- Exhibition in Visaginas Municipality – **“Stories of Rescued Pets”**.

- In protest against the exploitation of wild animals in circuses.
