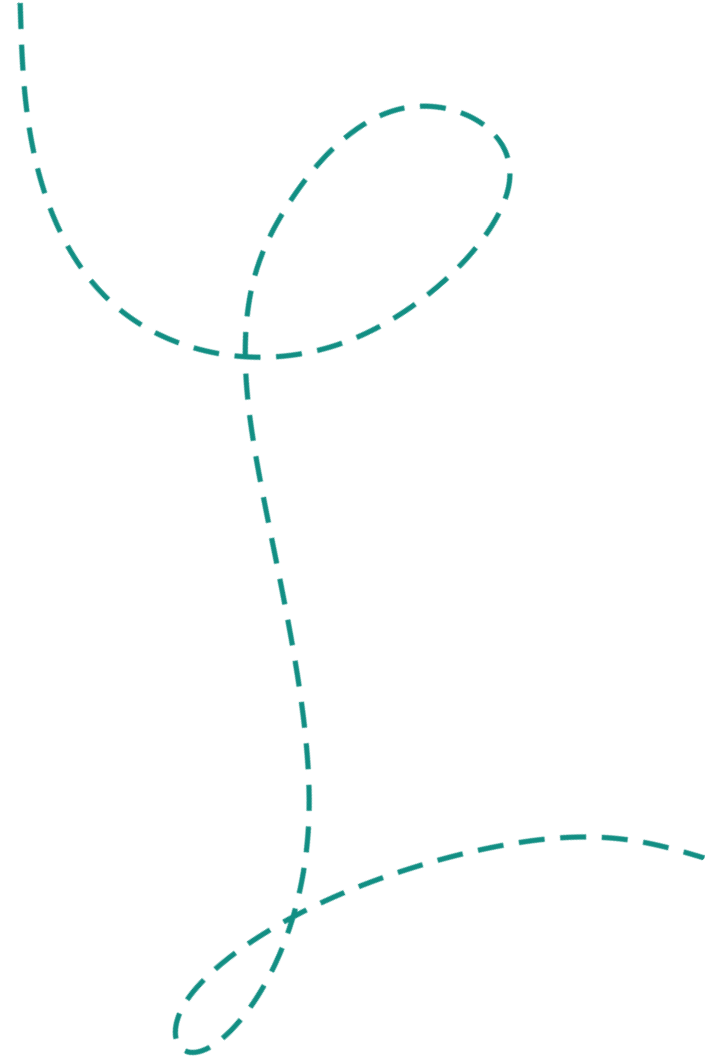

We aim to legalize an additional measure of impact – a ban on keeping animals for persons who have treated them cruelly.



WHAT WAS DONE IN 2021?





WORK DONE:

- ✓ We have appeared **in the media** more than **133 times**, speaking and educating the public on animal welfare topics
- ✓ We have published > **190 posts** on the organization's Facebook account.
- ✓ In the “neBrisius.lt” project, we photographed and told **63 stories**, of which 3 were about emigrating pets with their owners, 1 about animals with special needs | www.nebrisius.lt.
- ✓ We worked with **62 cases of animal neglect and cruelty**, of which 24 animals' living conditions were improved and/or the owner was punished in accordance with the procedure established by laws, in 14 cases there was a lack of evidence, as a result of which the cases were dismissed, 24 cases were still being resolved at the end of the year.
- ✓ We have consulted > **250** people on animal welfare.



WORK DONE:

- ✓ Together with member of the Seimas Ieva Pakarklytė, we continued the planned work in order to ban the keeping of animals by people who treat them cruelly.
- ✓ We submitted 6 proposals and comments to the Chancellery of the Government of the Republic of Lithuania regarding the Government's plan of measures, which includes aspects of animal welfare.
- ✓ We participated in the meetings of working group of the Ministry of Agriculture on resolution of problematic issues of animal welfare control.
- ✓ We prepared an analysis, in which we provided information, which municipalities have contracts with which organizations for the care of stray animals and confiscated animals.
- ✓ Together with other organizations, we carried out a joint project on mandatory marking of animals. We launched an advertising campaign.
- ✓ We coordinated a cooperation agreement with the SFVS, however, in the end, we didn't sign it because of the unsuitable conditions for us, i.e. for animal welfare.



WORK DONE:

- ✓ We carried out the project of Laisvės TV and GGI, by which aimed to systematically stop the illegal reproduction of animals and free animals from unjustified slavery.
- ✓ We have added 138 new places in Lithuania, which you can visit with pet animals. 1 new ambassador joined the project.

- ✓ We prepared the 2022 calendar of the “neBrisius.lt” project, which was decorated with photos of pets rescued and sheltered by our volunteers.
